- Road Maintenance Update 4 companies for propels (BNR, Empire, Nibrock, RL Workman)
- Work party by members to temporarily fill in areas along Chula Vista Rd and Rascal Ranch
- Bridge Flooding & Repair
- Rains from 8/19 & 8/21 water raised in wash and overflowed on the bridge. Cause was from debris
- Routine repairs were already being scheduled but the bridge became an immediate issue for member safety.
- Debris from rains was so dense and compacted we had to hire a company to use machinery to get clear from bridge area. RL Workman was able to come out right away and clear the area for a cost of \$2050.00
- The flooding also caused severe erosion on both east sides of the bridge causing a 6-10 foot drop
- Proposals from 5 companies are being gathers for the best price for building back the erosion add wire mesh and add a concrete cap.
- While waiting for the bids and board approval New signs at the bridge indication <u>One-Lane</u> <u>Bridge</u> until work is completed. With letters to members to show extreme caution while driving in this area.
- Cones and markings have been put in this area.
